



Puppy Deposit Contract

Pick placement of puppies is given according to the order of deposits received. Please verify by phone or e-mail that you are sending a deposit. Pick placements are held for 7-days while your deposit is in the mail. If your deposit has not been received within 7-days your puppy pick will be applied in the order your deposit is received. Puppy selection is made at the time of puppy pick-up. Puppy pick-up is at 7-weeks of age (weekend beginning Friday August 17th 2018). We typically do not do puppy visitation prior to puppy pick/pick-up. On the rare occasion we do visitations it will be on a case-by-case basis dependent on availability of time (sorry we work full time and typically do not have the free time required for visitation). ***Sire & Dam owner(s) reserve the right to first pick of the litter at any time.***

Your choice of puppy can be made by pictures, in person, or Young Labradors can pick a puppy for you according to your description and availability. Photos and videos of puppies from birth until placement in their new homes will be placed on our web site at www.younglabradors.com and on Facebook at www.facebook.com/young.labradors. Photos and videos for puppy selection can also be sent by e-mail or text messaging.

The puppy deposit for this litter is **\$200.00** and is non-refundable. The deposit will be applied toward the purchase price of **\$1000.00**. Checks are made payable to Mary Young. This deposit will hold the puppy until it has been weaned and is ready for pick up. The remaining balance of **\$800.00** can be paid at any time before or at the time of pick up. FINAL PAYMENT MUST BE MADE BY CERTIFIED CHECK OR CASH. NO PERSONAL CHECKS WILL BE ACCEPTED UNLESS RECEIVED 3 WEEKS BEFORE PUPPY PICK UP FOR BANK CLEARANCE.
